NOTICE OF DISMISSAL OF DEFENDANT INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS, AFL-CIO, LOCAL 2213

SuperMedia Inc., SuperMedia LLC, SuperMedia Services Inc., SuperMedia Sales Inc., SuperMedia Employee Benefits Committee, and Idearc Inceptor LTD (collectively, "SuperMedia" or "Plaintiffs") files this Notice of Dismissal with prejudice of all claims by Plaintiffs against Defendant International Brotherhood of Electrical Workers, AFL-CIO, Local 2213 ("Local 2213") pursuant to Federal Rule of Civil Procedure 41.

On August 2, 2012, Plaintiffs filed their First Amended Complaint - Class Action for Declaratory Judgment ("Complaint") (Docket No. 23), naming a number of defendants, including Local 2213. Defendant Local 2213 was served with process on August 10, 2012 (Docket No. 37). Defendant Local 2213 has not served an answer or a motion for summary judgment. On October 12, 2012, Local 2213 filed a Motion to Dismiss the Complaint (Docket No. 70).

On or about the week of November 12, 2012, Plaintiffs and Defendant Local 2213 reached an agreement of dismissal. A substantial controversy between Plaintiffs and Defendant Local 2213 no longer exists. Neither Local 2213 nor the remaining parties will be prejudiced by its dismissal from this action.

WHEREFORE, premises considered, Plaintiffs hereby request that the Court dismiss Defendant Local 2213 from this matter with prejudice to the re-filing of the same, pursuant to Federal Rule of Civil Procedure 41, and that any costs be borne by the party incurring them such that none of Plaintiffs' costs shall be taxed against Defendant Local 2213.
