## STIPULATION OF AGREEMENT BETWEEN PLAINTIFFS AND DEFENDANTS COMMUNICATION WORKERS OF AMERICA, AFL-CIO, LOCALS 1301 AND 1302

SuperMedia Inc., SuperMedia LLC, SuperMedia Services Inc., SuperMedia Sales Inc., SuperMedia Employee Benefits Committee, and Idearc Inceptor LTD (collectively, "SuperMedia" or "Plaintiffs") files this Notice of Agreement with Defendants Communication Workers of America, AFL-CIO, Locals 1301 and 1302 ("CWA").

On June 26, 2012, Plaintiffs filed their Original Complaint - Class Action for Declaratory Judgment ("Complaint") (Docket No. 1), naming a number of defendants, including CWA. CWA was served with process on July 5, 2012 (Docket No. 37). CWA has not served an answer or a motion for summary judgment. On August 30, 2012, CWA filed a Motion to Dismiss the Complaint (Docket No. 54). By agreement of the parties and order of this Court, Plaintiffs' response is due on November 16, 2012.

On or about the week of November 12, 2012, Plaintiffs and Defendant CWA reached an oral agreement of dismissal, but need more time in order to execute a written agreement.

WHEREFORE, premises considered, Plaintiffs and CWA hereby request that the Court extend the time for Plaintiffs to respond to CWA's Motion to Dismiss for five (5) days so that the parties may execute an agreement regarding dismissal, pursuant to Federal Rule of Civil Procedure

41.
